

## ID TECH AMENDMENT

### ARTICLE I PREAMBLE

- 1.1 **Adoption and effective date of amendment.** The Employer adopts this Amendment to ID TECH Flexible Benefits Plan (the "Plan"). - 1.3 **Construction.** Except as otherwise provided in this Amendment, any reference to "Section" in this Amendment refers only to sections within this Amendment, and is not a reference to the Plan. The Article and Section numbering in this Amendment is solely for purposes of this Amendment, and does not relate to any Plan article, section or other numbering designations.

### ARTICLE II ELECTIONS

- 2.1 **Effective Date.** The provisions of this Amendment, unless otherwise indicated are effective as of January 1, 2022.
- 2.2 **Plan Amendment.**

#### **Health Care Flexible Spending Arrangement- Indexed Carryover.**

The Employer hereby amends their plan Carryover to the inflation adjusted maximum amount for Health Care Flexible Spending Arrangement and Limited Health Care Flexible Spending Arrangement effective January 1, 2022.

For future plan years the Health Care Flexible Spending Arrangement and Limited Health Care Flexible Spending Arrangement Carryover maximum will automatically increase to the indexed amount.
